Predictive Services Discussion: Gusty offshore, easterly winds of 20-40 mph with minimum relative humidity of 20-35% are likely through the morning on western slopes of the Cascades in Washington and Oregon and may continue into the evening, with increased fire activity again likely on large fires in the region. Onshore flow should move into portions of western Washington and Oregon tonight, but poor to moderate humidity recovery is likely to continue in much of the Cascades, especially along and east of the crest. Above normal temperatures and minimum relative humidity of 8-25% are expected across much of the Great Basin, northern California, and the Inland Pacific Northwest as well. Warm and dry conditions are expected in portions of the Florida Panhandle, Georgia, Alabama, and South Carolina. Thunderstorms and showers, including areas of heavy rain and flooding, are likely in much of the Southwest, Texas, southern Oklahoma, and extending through portions of Arkansas, Tennessee, the central Appalachians, and the Mid-Atlantic. Isolated showers, including possible snow, are likely in portions of the Great Lakes.

Helicopter Landing Area Safety



Aviation Category

The following points should be considered when operating around an unimproved landing site: Is the helicopter a Type 1? For larger helicopters, increase the distance ground personnel must standby from the drop zone.

- Always wear your personal protective equipment (PPE) when working near an operating helicopter (eye, hearing, head, etc.).
- Always get the approval of a flight crew member or the pilot before approaching an operating helicopter.
- Only approach and depart a helicopter as directed. Use a slightly crouched position. Do not run. Always keep in the pilot's field of vision.
- Never go near the tail of helicopters.
- When loading helicopters in uneven terrain, always approach and depart from the down slope (lower) side and do not hold equipment overhead.
- Remove or secure loose articles prior to working around an operating helicopter.
- Do not reach up for or chase after loose objects.
- Blowing dust, sand, or rocks caused by the helicopter's rotor wash can be hazardous. Institute dust abatement actions at the landing area if necessary.
